Position overview

The Hair & Beauty Trainer and Assessor delivers practical and theoretical training in qualifications such as SHB30221 Certificate III in Hairdressing, SHB30121 Certificate III in Beauty Services, and SHB30221 Certificate III in Makeup. This role fosters technical expertise, creativity, and professional behaviour in learners, ensuring they are prepared for employment in salons, beauty clinics, or freelance roles. The Trainer and Assessor also ensures compliance with the Standards for RTOs 2015 and aligns with industry best practices.

Key responsibilities

Training delivery

- Deliver engaging and interactive training sessions in hair styling, colouring, cutting, beauty treatments, and makeup artistry.
- Facilitate hands-on practical skills development in simulated salon environments using professional tools and products.
- Incorporate customer service and hygiene best practices into training sessions.
- Create a safe and inclusive environment that fosters creativity and professional growth.

Assessment

- Conduct competency-based assessments aligned with the training package requirements.
- Develop, validate, and improve assessment tools to ensure they meet the principles of assessment and rules of evidence.

- Vocational qualifications in hairdressing, beauty therapy, or makeup (Certificate III or above).

Experience

- Minimum three years of recent, relevant industry experience.
- Previous experience in delivering training or coaching is advantageous.

- Excellent organisational skills, with the ability to balance multiple responsibilities effectively.
- Proficiency with Learning Management Systems (LMS) and digital tools for education delivery.
